Brown's massive banking scam

Brown has already spent £600 billion and is now about to pawn Britain for £900 billion to a corrupt supranational private banking cartel. Brown has just announced a £2-3 billion support package, including insurance to cover the bankers 'toxic' debt. Something smells. RBS and HBOS look likely to announce

Eighty three per cent say British law should be paramount

Majority say UK politicians "don't do enough to stand up for Britain"

The overwhelming majority of Britons want a referendum on whether the UK stays in the European Union.

A new poll by ComRes, commissioned by the Campaign for an Independent Britain (CIB), shows support for the EU at rock-bottom.

Most voters are deeply unhappy about the way the European Union is run, and believe it is out of touch, unfair, and offers poor value for money.

The poll is a devastating blow to those in the Government who want to deepen the UK's involvement in the EU by taking Britain into the euro zone.

But it is also bad news for the Conservatives as it shows the electorate have moved beyond Tory policy on Europe and are far more Eurosceptic than the present Tory leadership.

With half of voters saying Europe is "largely corrupt", 71% of those polled say they want a national referendum to decide whether Britain remains in the EU.

Seventy five per cent think UK politicians "don't do enough to stand up for British interests in Europe". The same proportion views the EU as "out of touch".

Sixty five per cent feel that the UK "gets an unfair deal in the European Union; we play by the rules but nobody else does".

Only 29% believe that Britain gets good value for money from its membership of the EU.

Sixty three per cent say that the EU stops Britain from having its own immigration policy, and an overwhelming 83% are opposed to European law overriding UK law.

Commenting on the results, George West, Chairman of the Campaign for an Independent Britain, said: "The results come as no

surprise, proving that the 2.4 billion euros of taxpayers' money that the EU spent in 2008 alone on promoting itself and its central aim of 'ever closer union' was money thrown away. No amount of EU flag waving, singing the EU national anthem 'Ode to Joy' or EU brainwashing will ever win over the hearts and minds of British people who were told in 1972 that they were joining nothing more than a trading Common Market."

The poll results were welcomed by leading Eurosceptic Members of the European Parliament. Nigel Farage, Leader of the UK Independence Party (UKIP) and MEP for the South East of England, commented: "This poll shows how hopelessly out-of-touch our politicians are with the public. The need for a referendum, on fundamental issues of sovereignty, has never been greater."

Roger Helmer, Conservative MEP for the East Midlands and Chairman of The Freedom Association, added: "I am delighted at this further confirmation that the British people demand a say on the EU. The EU's frantic attempts to deny citizens a say on the Lisbon Treaty are despicable. Their contempt for the voters is breathtaking."

YouGov survey shows voters "antagonistic" to EU.

Two thirds want an end to supremacy of European Court of Justice and a loosening of Britain's ties to the EU itself. A staggering 45% of voters believe none of the three main parties adequately reflects their views.

Loosen Britain's ties with European Union, say two-thirds of voters.

Almost two-thirds of voters want a significant loosening of Britain's ties with the European Union including an end to the supremacy of the European Court of Justice, a new opinion poll reveals.

The YouGov survey for the TaxPayersAlliance and Global Vision, the Eurosceptic pressure group, shows that voters remain antagonistic towards the EU in the wake of the Lisbon

Treaty, which increased the powers of Brussels at the expense of national governments, as well as towards the euro, despite recent falls in the value of the pound.

The survey – released exclusively to The Sunday Telegraph – also spells out the threat posed to the Tories by the United Kingdom Independence Party (UKIP) in elections to the European Parliament which take place on 4 June. Ten per cent of those who would vote Tory in a general election will back UKIP in the euro-election, the survey suggests.

David Cameron has been trying to "close down" Europe as

a political issue amid fears that traditional Tory divisions on the subject could resurface with the possible return of Ken Clarke, the strongly pro-Brussels former Chancellor, to the shadow cabinet.

Overall, 16 per cent of voters want Britain simply to withdraw from the EU, while 48 per cent would like to see a much looser relationship, with the government taking back powers from Brussels and ending the supremacy of the European Court of Justice over British law.

Added together this makes 64 per cent in favour of weakening Britain's ties with the EU, compared with just 22 per cent in favour of keeping the UK's current full membership including the Lisbon Treaty, which was passed by parliament without a referendum.

Asked if they favoured joining the euro, in the wake of the slump in the value of the pound which at one stage brought it close to parity with the single European Currency, 64 per cent said No, with 24 per cent backing euro membership, a finding broadly in line with a BBC opinion poll earlier this month.

In the first study of voting intentions for the European parliamentary elections in June the Tories are on 35 per cent, six points ahead of Labour on 29 per cent with the Liberal Democrats on 15 per cent and UKIP on 7 per cent. Then come the

Greens (5 per cent), the British National Party (4 per cent) and nationalist parties in Scotland and Wales (also 4 per cent).

Significantly, 10 per cent of Conservative voters at a general election would switch to UKIP in the euro-election, compared with 2 per cent of Labour voters and 1 per cent of those backing the Lib Dems. Conservative support could fall still further if Mr Clarke makes a front-bench return, using his position to make high-profile interventions on European matters.

Some 45 per cent of voters, meanwhile, believe none of the three main political parties adequately reflects their views on Britain's future relations with the EU, while 59 per cent of the population believes ministers should disregard the EU's VAT rules if they feel a further cut in VAT is necessary in this year's Budget. The current rate of 15 per cent is the lowest permitted by Brussels.

Matthew Elliott, chief executive of the TaxPayersAlliance, which with Global Vision has launched a campaign to propel European issues up the political agenda in the coming weeks, said: "The main political parties have let people down by avoiding or fudging the EU issue, but it has such a big impact on our day-to-day lives that it must be dealt with."

It is now over two weeks into the Israeli war on the people of Gaza. More than 1300 Palestinian men, women and children, and no doubt some leaders of the militant group Hamas are dead, as compared with a handful of Israelis, some damaged buildings and disrupted lives in Israel.

Does the UK Column condone violent Hamas attacks on Israel - definitely not - but a comparison to this Israeli atrocity would be the British RAF bombing Belfast, because of a terrorist attack in Manchester. That Israel can murder on this scale, with the blind eye of Britain and America, is despicable.

Tony Blair has of course revealed himself to be the usual puppet of the new world order banking elite, which is keen to stoke up the Israeli action to help divert attention from the global banking collapse.

While many are reticent about commenting, or being drawn into the debate about the “Israeli / Palestinian issue,” the brazen, wanton, criminal atrocities that are being committed in this sick business by the superpower of the region are simply too heinous to be ignored. It is not enough for Israel to hide behind their historic suffering, when their actions are so vicious and unacceptable today, Jewish politicians and their lobbyists in the West, must be made fully accountable. No doubt, the smirking Mr Blair has failed to stand and be counted due to US and home grown lobbying pressure. Just where did New Labour funds come from? No doubt also, that the UN has also failed to take action due to the powerful US/Israeli lobby.

What world press fails to report, and the British press and media are no exception, is the concern of many Jews as to the character of their government and the lack of democracy in Israel. Israel’s clamp down on reporting in the area, apart from a few obvious ‘locals’ chosen by the government, has seen to that.

On a deeper level, what is it about the Israeli national political character, the “siege mentality,” that violence and murder against civilian populations can be pursued with

such inhumane and calculated precision? How can a culture that produced Jesus Christ be so immune to the cries of the dead, maimed and dying - in the prison camp they have created, of what remains of the country they annexed from the Palestinians, so long ago?

Well, one possible answer is to be found in the secret Jewish law/doctrine of the Talmud, which itself is every bit as racist and anti-human as anything written by their most recent nemesis and persecutor, Adolph Hitler. Quite clearly, it is a small minority of Jews, both within the global extended diaspora, and within Israel itself, that subscribe to such ideas, or indeed support this current, self destructive madness. But what does it say of us, the formerly “free west” that we have permitted the infiltration, and in some cases the virtual takeover of our formerly “Christian” national political systems, by a minority of adherents of such racist and supremacist ideologies. Have we become so blind that we cannot see the enemy in our midst?

But leaving aside such complex cultural, religious and historical factors for now to focus on the strategic picture, it is clear that on this occasion, the inherent instinct for self preservation against all opposition or rationality has forced the Israeli leadership into a disastrous course of action that will lead to incalculable consequences if peace is not restored in very short order. We hope that the ceasefire as of 18 January 2009 holds.

If it does not, we again risk the spread of Israeli troops, described in earlier reports as “massing at the border”. Any such expansion of the conflict beyond Gaza can only be interpreted as a deliberate attempt to draw other regional powers into a growing and unstoppable conflagration. As such, the timing of these operations can no longer be considered to be accidental. With the change in government underway in the United States, forces are now in motion that are determined to force the hand of the incoming President Obama to guarantee that no alternative to a 100 years war between the “Western” powers and those of the “East”, vectored on a vicious and perpetual religious and sectarian conflict in the world’s major oil patch, were ensured.

If there were any serious doubt or skepticism as to the truth of this statement, I refer you to the following blatant statement on the subject by the London Economist, the leading mouthpiece for the City of London financial oligarchy.

“There is a limit, however. Taking Hamas down a peg is one thing. But even in the event of Israel “winning” in Gaza, a hundred years of war suggest that the Palestinians cannot be silenced by brute force. Hamas will survive, and with it that strain in Arab thinking which says that a Jewish state does not belong in the Middle East. To counter that view, Israel must show not only that it is too strong to be swept away but also that it is willing to give up the land—the West Bank, not just Gaza—where the promised Palestinian state must stand. Unless it starts doing that convincingly, at a minimum by freezing new settlement, it is Palestine’s zealots who will flourish and its peacemakers who will fall back into silence. All of Israel’s friends, including Barack Obama, should be telling it this.”

I will leave our readers to ponder these issues by way of a reminder from history, the following excerpt from ***Zionism versus Bolshevism***, by none other than Winston S Churchill, a perspective which we neglect at our direst peril.

“In violent opposition to all this sphere of [positive] Jewish effort rise the schemes of the International Jews. The adherents of this sinister confederacy are mostly men reared up among the unhappy populations of countries where Jews are persecuted on account of their race. Most, if not all, of them have forsaken the faith of their forefathers, and divorced from their minds all spiritual hopes of the next world. This movement among the Jews is not new. From the days of Spartacus-Weishaupt to those of Karl Marx, and down to Trotsky (Russia), Bela Kun (Hungary), Rosa Luxembourg (Germany), and Emma Goldman (United States), this world-wide conspiracy for the overthrow of civilization and for the reconstitution of society on the basis of arrested development, of envious malevolence, and impossible equality, has been steadily growing.”

If Mr Churchill’s observations and fears were correct then, the Western World would do well to help ensure that they are not still correct today. The risk of a major middle east conflagration is as great to the West as it is to the ordinary Jewish people themselves. The same can be said for an escalation of hatred between all Christians, Jews and Muslims.

Are we, but more importantly, the Israelis themselves, so foolish as to forget the lessons of malevolent dictators in two world wars, as the flames leap higher?

We're told the "credit Crunch" is because banks lent too much money, and depleted their balance sheets to the point of bankruptcy. We're told that the banks won't lend to each other, or to us, because they need to strengthen their balance sheets before they can start lending again. Lies, lies and spin.

We WERE told that the banks were obliged to lend at 2007 levels as a condition of giving them billions of pounds in bailout money.

Banks won't lend - can't lend

The banks won't lend. They can't lend. Because the banks' senior management know the truth - this is not a credit crunch. It is a systemic collapse. They have been trading whilst insolvent. A crime for which a market trader would be charged.

Bond & Derivatives Market to Collapse

We have already seen the housing market, mortgage market, commodities market, stock market and Sterling collapse. These will soon be followed by the bond market and the derivatives market.

The knock on effect of the show so far is that well known high street firms, such as Woolworth and Wedgwood, have gone out of business, and tens of thousands are losing their jobs each day.

The initial effect on the real economy will be deflationary. In order to shift stock, businesses will be forced to reduce prices. This is, say the government, the nightmare scenario. They

say that if inflation should fall into negative territory, the effect will be an ever greater reluctance of people to spend, while they wait for further price falls. They say this on the assumption that an economy is a system where the primary driver is people spending money, rather than producing goods.

After the deflation will come hyperinflation. Zimbabwe/Weimar republic style hyperinflation. The real nightmare.

With inflation falling fast, and interest rates faster, our morally, as well as fiscally, bankrupt government is only permitted to steer one course in their efforts to fight the deflation - expand the money supply.

Printing Money

Printing money, or "quantitative easing" as it has come to be known, has never been a successful strategy at any time in history. But in

preparation for turning on the printing presses, the government is ramming The Banking Bill through Parliament right now. This bill abolishes a key section of the law laid down by Robert Peel's Government in 1844 which originally granted the Bank of England the sole right to print Sterling.

Bank of England to hide accounts

The Banking Bill removes the obligation of the Bank of England to publish its balance sheet on a weekly basis. This means there will be no easy way for us to keep track of the UK's money supply. Once the printing presses are started up, there will be no obligation to report how fast they are turning.

Lord James of Blackheath, a Conservative peer, said during a recent debate in the House of Lords, "Remove [this] control and there is nothing to stop an unreported and unmonitored flooding of the money market by the undisciplined use of the printing presses.

"If we went down that path we would be following a road which starts in Weimar, goes on through Harare and must not end in Westminster and London. That is the great

four days after becoming Chancellor. What was that, then? A debt paid perhaps?

Independence allows the Bank full control of monetary policy. Sold to the public as a "good thing," this means that government has no control over a very large slice of the economic pie. Would you give your salary and savings to someone outside of your control?

So who controls the Bank of England?

The answer to that question is simple. The Bank has a Governor, Deputy Governor and a Court of Directors. It also has a monetary policy committee. Worryingly these are all private bankers - not a civil servant amongst them, and no government representation. The best the government can hope for is to receive a friendly letter if inflation falls outside the target range, explaining why. Nice of them to tell us.

Court of Directors, Monetary Policy Committee

Nathan Mayer Rothschild said "I care not what puppet is placed upon the throne of England to rule the Empire on which the sun never sets. The man who controls Britain's money supply controls the British Empire, and I control the British money supply."

How interesting that the present Mr Rothschild is a very close adviser to Gordon Brown.

When the Bank of England was given independence, private bankers were not only given full control of Britain's money supply, they were given control of monetary policy as well. And because private bankers are in control, those same private bankers who would lose the most if any real solution to our financial and economic woes were to be put in place, they permit the government only one option.

Debt caused the problem, so Gordon says...let's have more debt.

Our personal debt is currently in excess of circa £1.5 trillion. On top of that, we have corporate debt and the national debt. Then there is derivatives debt (between one and two QUADRILLION dollars?) and the debt of outstanding short-sold stocks, bonds, commodities and currencies. The system is collapsing under the weight of all this debt, and Gordon Brown, the Global Chancellor of the Exchequer, has been promoting the one option available to him for all its worth - fix the symptom, get the credit markets flowing again. We need more debt!

How can we, the poor British public, slay this debt monster?

The only nation on this planet which is Constitutionally entitled to utter its own money is the United States. Two Presidents, Lincoln and Kennedy, tried to do exactly that. They both

ended up dead.

Unlike in the USA, we have no Constitutional authority to take that role away from the Bank. We would have to legislate.

Immediate legislation to throw out private bankers.

We need to legislate now. We need to throw the private bankers out of the Bank of England. End fractional reserve banking, speculation and corruption. We need to set up a system whereby CREDIT is issued to business (not DEBT!) at a low percentage SIMPLE interest.

We need to take all the failed high technology businesses we have - in aerospace, transport etc, and re-employ the remaining skilled workforces they have building high tech solutions to our economic infrastructure problems. We need nuclear power, and an education system that can produce the kind of science graduates required to operate nuclear power stations. (Did you know the average age of a nuclear industry employee is over 50?)

We certainly need to restore our British capability to manufacture weapons and ammunition for British forces.

Write off speculative debt for everyone.

We need, as a matter of urgency, to write off all speculative debt and close those departments in banks involved in speculation. We need to protect the high street banks that provide the service we all use.

Re-establish our full manufacturing base from steel to ice-cream.

Finally, free of the artificial burden of speculative debt, we need to turn ourselves back into a producing nation. The financial industry and services economy was always a scam, and now we are realising just how big a scam. Factories can be dirty and smelly, but is the smell as bad as the present stench of the City of London?

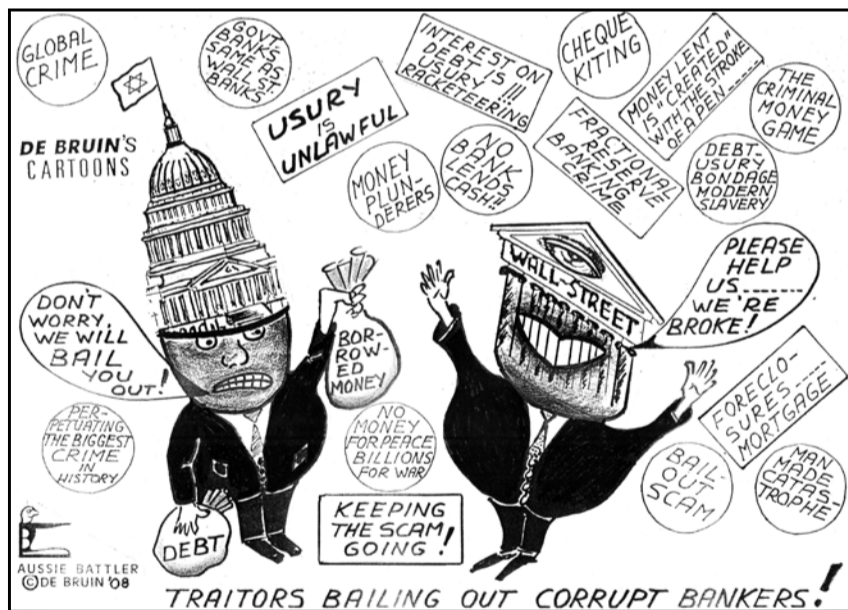
Public Inquiry.

Before we can do any of this, we need a full and open public inquiry to expose the full extent of the fraud and corruption within Parliament, Banks and the City of London. It must be fully independent and fully public.

Bank or Parliament - Who drives who?

The Bank of England was nationalised in 1946. In return for giving up ownership, stockholders were given government stock returning 3% per year. There was an option to redeem this government stock from the stockholders at any time after 1966, but that option has not been taken up. In the meantime, about 50% of the government stock has gone back to the government for one reason or another.

The public might assume, as a result of this, that the Bank takes its orders from the Treasury. Many informed financial people are uncertain whether the Bank ever did take orders from the Treasury, but in 1998, the Bank was given its "independence," following an announcement by Gordon Brown, made just

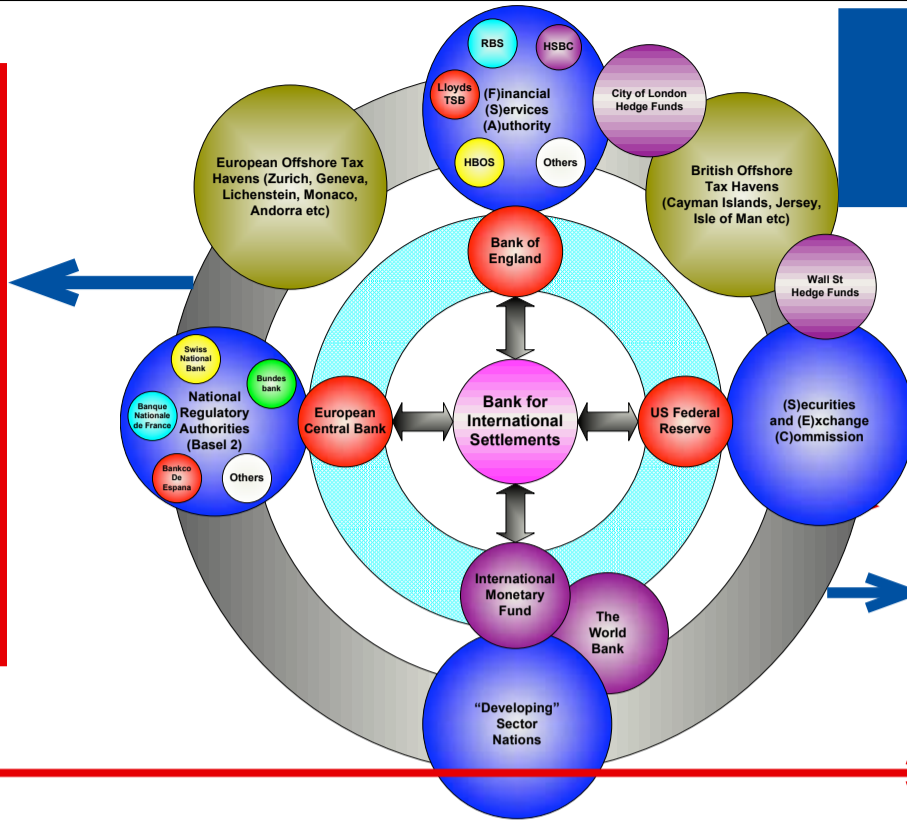

I look at Article 5 of the Treaty of Velsen; Eurogendfor (EGF) may be placed at the disposal of the European Union (EU) and also of the United Nations (UN), the Organisation for Security and Co-operation in Europe (OSCE), the North Atlantic Treaty Organisation (NATO) and other international organisations or an ad hoc coalition. So basically Eurogendfor may be put into use anywhere that may be deemed a crisis situation by the EU, perhaps a country that objects to EU Treaties or Legislation, especially if the Lisbon Treaty is ratified, or perhaps NOT ratified?

Article 16 (2) Eurogendfor Personal may possess, carry and transport arms, ammunitions, other weapon systems

and explosives on the conditions that they are authorised to do so by their orders and that they do so in accordance with the laws of the Host State (HOST means the Party on whose territory the permanent HQ is located) and the Receiving State (The Party on whose territory EGF Forces are stationed or in transit).

Eurogendfor has many Privileges and Immunities, (Art 19). Individual Privileges (Art 20) and they also have Inviolability of the premises, buildings and archives (Article 21). In other words, Eurogendfor can basically do what it wants. Dont you wish all of us had the right to do what we want? If they come crashing into your house in the dead of night, we might all wish our premises too were inviolable. (For now, they cannot do this in the UK)

I believe even the innocent have much to fear, perhaps more so than the Criminal because criminals know the risks they are taking when they set out to break the law.

My thoughts turn to my memories of how I watched newsreels of the Gestapo in action during world war two. Some tried to have us believe they were just propaganda films. Now? Who would have thought this kind of thing could happen in peacetime? Or Here in the United Kingdom of Great Britain?

Rats to leave the sinking global banking ship?

HSBC: Nasty, Brutish Rats And Proud Of It

HSBC, the British bank, took out a full-page ad in The New York Times Magazine featuring a large, ugly rat--three pictures of the rat, actually, each with one of the words "free-speech", "camaraderie" and "clout" superimposed. We're not sure exactly what message HSBC is trying to convey here, but given the nasty nature of the bank, we suspect they are both bragging and issuing a threat.



HSBC Holdings plc is the holding company which arose from the Hong Kong and Shanghai Bank, the notorious flagship bank of the British East India Company's opium trade. The Hong Shang, as it was known, became perhaps the most powerful bank in the world, thanks to the extraordinary profits it has reaped from the opium trade.

Spreading misery for profit is the primary business of the British Banking Empire, so we can only presume that the ugly, aggressive, red-eyed, sharp-toothed rat in the HSBC ad reflects the oligarchs' intent in the coming period. You want free speech, camaraderie and clout? Well, we rats of the empire are going to destroy your free speech, your camaraderie and your clout, and then we're going to destroy you.

Back in May, the Bank of England's Mervyn King warned that "the nice decade is behind us," and now HSBC is issuing a warning of its own. As the financial crisis spins out of control, the imperial rats are being unleashed to spread chaos around the globe.

HSBC has also recently called for Central Banks To Bail Out The Derivatives Market. Describing the primary problem facing the global financial system as "a shortage of money," HSBC managing director of economics Stephen King then asserts that the solution "has to be monetization. The printing press has to be turned on." King makes these assertions in his column in today's London Independent.

"[T]he financial crisis is mutating.... It is fast becoming a crisis of liquidation.... we're edging toward a world of deflation," King says, adding that "the overall volume of lending is inevitably coming down" and that "companies, households and investors fear a shortage of cash. Any cash they've got, they hang on to. Any cash

they need, they raise via the sale of other assets which can be swapped into money. Panic takes over."

That is a fair description of the reverse-leverage blowout now under way, which is centered in the multi-quadrillion-dollar derivatives market. The problem facing the derivatives speculators is that there is nowhere near enough money in the world for them to cash out their fictitious winnings. Whereas the obvious solution is to shut the derivatives markets down, King views the matter from the parasite's perspective, and instead demands that the central banks take charge and print as much money as necessary to cover the derivatives claims.

"The printing press has to be turned on," King insists, saying: the problem in our newly deflationary world is a shortage of money." He admits that such a policy could cause "hyperinflation, as Germany's Weimar Republic discovered in the 1920s and Zimbabwe has discovered today," but dismisses that danger by claiming that "These, though, are exceptional times." King further states that, "to make the policy credible," it "should not come from finance ministers but, instead, from the world's central bankers."

In effect, King is demanding that the central banks save the speculators by printing as much money as is necessary to save their funny money, leaving it for the nations and their peoples to pick up the ultimate tab. This is a prescription for both a global bankers' dictatorship and savage, crushing austerity upon the population of the world. No wonder HSBC is calling for a new Hjalmar Schacht. Are gramscian fascists in need a new 'further' to implement their plan.

The British bank Lloyds has admitted it systematically cooked its books to let billions of dollars from Iran flow undetected through New York banks between 2001 and 2004 in violation of US sanctions - and now must pay a \$350 million fine and help the feds track the money, officials announced yesterday.

So far, none of the Lloyds money has been linked to terrorism, Manhattan District Attorney Robert Morgenthau said.

But Morgenthau said his office and federal officials were probing the New York activities of nine other European banks, some larger than Lloyds.

Money passing through one of these banks has been traced to a massive purchase of tungsten, a vital component of long-range missiles, Morgenthau said.

Under its agreement with state and federal officials, Lloyds admitted it routinely "stripped" the identifying information from wire transfers of money of Iranian origin passing in and out of New York.

"This investigation is important for two reasons," Morgenthau said. "We hope it's a deterrent for other banks considering this kind of stripping operation. We also want the public to understand the extent of the Iranian efforts to make purchases overseas."

Analysis of the workings of the EU

No to a common Foreign and Security policy (CFSP) of the EU

The foremost reason for why Britain should not cede its right to make its own foreign policy to the EU is, of course, that Britain would cease to be sovereign. But here's another reason for why not: the EU is a disastrous steward of foreign affairs of its member states. It's been given a trial run, but it has failed. Europhiles are continually claiming that only the EU, and not individual member states, could be respected and obeyed abroad, and that only collectively could it influence the outside world. This is not true. Here are ten exemplary reasons for Britain to withdraw from the EU's CFSP:

1) Iran: The EU claimed that only it could resolve the Iranian nuclear crisis. It has failed, though. The EU has not imposed any sanctions on Iran, and has not wielded any hard power against it, only soft power (diplomacy). It has dispatched the EU's supranational foreign minister (Javier Solana, a dovish Spanish socialist) and his staff to convince the Iranians to cancel their nuclear program, but it has failed. If anything, Iran has been emboldened by the European equivocation. According to various sources, Iran is no farther than 2 years away from its first nuclear warhead, which it may obtain in 2009 at the earliest. Ahmadinejad will then be able to nuke Israel as he threatened to. Speaking of Ahmadinejad, he has been allowed to travel to the EU (e.g. to Rome, for the FAO summit) and deliver anti-Israeli speeches to European audiences.

2) The March 2007 crisis: when 15 British military personnel were captured by the Iranians, the EU, rather than help one of its members (who also happens to be a member of NATO), decided to back the Islamic Republic and protect its sizable investments in Iran. The EU's solidarity claims and the solidarity clauses of its various treaties like the Lisbon Treaty, are not credible. The EU has NEVER helped Britain anyhow, and NEVER will.

3) Zimbabwe: The EU waived its own travel ban on Zimbabwean officials to enable Zimbabwe's dictator, Robert Mugabe, to come to Europe for an EU-Africa summit. Only the British Prime Minister boycotted the summit. (During his electoral campaign, French President Sarkozy said that defending human rights would be his priority, but he's proven himself to be a despicable liar.)

4) Cuba: Recently, the EU abolished its sanctions against Cuba, thus contradicting the requests of Cuban dissidents. The only state to oppose the abolition was Poland, whose Foreign Minister, Radoslaw Sikorski, was instructed by his Prime Minister to veto the abolition unless Poland would find itself alone. It did: all 26 other EU member states categorically demanded that the sanctions against Cuba be abolished. Faced with such an onslaught, and the threat that Poland would be isolated in the EU, Radoslaw Sikorski withdrew his veto. Did the abolition of sanctions make the EU a friend of Cuba? No, because the only prize Cuba gave the EU was Cuba's scorn. This supranational megastate is afraid to take on Cuba, a tiny Communist

country. How can the EU be expected to defend itself, or take on, for example, Russia, if it can't even act toughly against Cuba?

5) Trade: The EU is strangling world trade (not just its own trade with the outside world). If the UK was a sovereign state, it could negotiate trade deals on its own, but as a member of the EU, it can't. Although the EU's Trade Commissioner, BRITON Peter Mandelson, favours free trade, he's lonely among the EU's 27 commissioners, and is facing hostile Continental governments except the Dutch and Swedish ones. In fact, Nicolas Sarkozy has started a propaganda war against Mandelson and threatened to sack him as a Commissioner. As per the orders of the EU, Mandelson was forced to offer no good deal to foreign leaders and to make the Doha round fail. Sarkozy has also ensured that the EU will not even reduce, let alone abolish, its lavish farm subsidies, thus forcing the US to maintain its own agricultural subsidies. The EU's and America's protectionist agricultural tariffs will also remain on the books because of the French. Thus, the EU has worsened its own relations with the US but also with developing states like China, India and Brazil. Britain cannot afford to maintain bad relations with India (which will be the world's most populous country in 2050) nor Brazil (South America's most populous state).

6) American elections: The German government has announced it will meet with Obama, but not McCain, and has allowed Obama to speak at either the Brandenburg Gate or the Rathaus Schoeneberg, which permission amounts to an endorsement of Obama, which is an undue interference in a foreign presidential election (<http://elections.foxnews.com/2008/07/09/obama-to-speak-in-berlin-during-european-tour/>). The election of a nation's president should be decided solely by that nation.

7) Global warming: The EU has worsened its relations with the US and the rest of the outside world in another way, too. It wants developed (but not developing) countries to adopt harsh obligatory emission reduction goals, and is constantly claiming that global warming is true and that it requires such targets. It also claimed that the US is 'isolated' on this issue. But the US is not the sole G8 country opposing such emission reduction goals, because so do Canada, Japan and Russia. So within the G8, it's a four-four split. Beyond the G8, China, India, Brazil and other developing countries also oppose such obligatory goals, so if anyone is isolated, it's the EU. Therefore, far from making itself, or Britain, more respected, more influential and farther-outreaching, the EU will only make itself, and Britain, isolated.

8) Industries: To end 'global warming', which may not even be true, the EU has sacrificed its own industry. It has strangled it with onerous regulations, usurious taxes (including so-called 'green taxes') and emission reduction targets.

9) Russia: The EU has emboldened Russia's communist government. Russia is building two natural gas pipelines which will make the EU dependent on Russian gas; this was possible because Russia's FSB (the KGB's successor) has enlisted the former German Chancellor, Gerhard Schroeder, who now works for Gazprom as an executive. Russia is also exporting coal to the EU. The

EU has refused to wean itself off Russian fossil fuels, though, and has also pursued a dovish foreign policy towards Russia.

10) Galileo: The EU has started this satellite program to create a constellation of satellites which China (a participant of the program) could use against the US, which has been irked by this. Once again, the EU has worsened its own relations with a country of 303 million people, this time for the sake of a regime with appalling human rights record.

The EU is a disastrous maker of foreign policy. For the false promise of good relations with European states, Edward Heath led Britain into the EU, which has worsened Britain's relations with most other European countries in the world.

The EU is not a Superpower

Editorial Comment. This article should be read taking into account that the economic performance described is before the current world global meltdown. Mr Mazurak's analysis stands, that where countries take control of their own affairs they perform better than in an artificially constructed (EU) economic framework.

With the US experiencing a cyclic economic 'slowdown' and with the accession of 12 new member states, many American and non-American economists have claimed that the dominance of the US is over and that the EU will be the world's new principal economic juggernaut. However, these claims are based exclusively on aggregate, pan-European statistics, which conceal the fact that it is the brilliant performance of just a few member states that has boosted the EU's stats.

For example, Ireland has reduced state spending, balanced its budget, paid its debt and lowered the CIT, the result being a GDP per capita higher than that of America and 6% economic growth. If Ireland was an American state, it would be one of the richest. Britain reformed its economy during the 1980s and is now experiencing 3% economic growth. If Britain left the EU, then the megastate's economic statistics would have been significantly worse. Most of the 12 newest EU members have adopted a flat tax, reduced state spending and their debts, balanced their budgets, and completely privatised their economies. (Poland is one of the few exceptions). They have, likewise, achieved good results.

However, most EU member states - including France, Germany and Italy - have failed to reform their economies anyhow. For example, French President Nicolas Sarkozy has removed 'undistorted competition and trade' from the EU's list of goals stated in the Lisbon Treaty, and he

did not even try to deny his real reason for why he did so. 'The word <<protection>> is no longer a taboo', Sarkozy said.

The results are dismal: high unemployment, sluggish economic growth, huge annual budget deficits, huge state debts and declining foreign investment. For example, money is being withdrawn from Germany and invested in Britain BECAUSE Britain is not a eurozone state. In France, unemployment stands at 7%, and in some areas it's as high as 50%. France has not had a balanced budget since 1980, and its debt already stands at 66% of GDP, as does Germany's. Italy's debt already stands at 105% of GDP, and Belgium's at 90% of GDP.

And for these EU states, the future will be even worse. The governments of 9 EU states have signed a declaration that demanded stronger 'social, environmental and work protections' - which will only make their economies less competitive and reduce economic growth. They will

The EU is just like the Soviet Union. Its successive appointed dictators (except Gorbachev) were dogmatic socialists who failed to reform the USSR. When Gorbachev took the Kremlin over, it was too late to reform the USSR, which collapsed just 6 years later. Its successor, Russia, is still a poor state. Why should the British people be subjects of another socialist megastate?

Press release: Elizabeth Beckett lays treason charges against Gordon Brown

On 22nd July, Elizabeth Beckett laid charges of "Misprision of Treason" against Gordon Brown at the Newcastle Magistrates Court, on the ground that he forced her majesty against her coronation oath to agree the Lisbon Treaty (EU Constitution).

According to the Daily Express on Fri 18th July ("Brown forces Queen to sign away Britain's sovereignty in secret.")

In this article William Hague said: "Gordon Brown has no democratic or moral authority to sign Britain up to what is a renamed EU constitution. This move is a total breach of trust with the British people and a flagrant breach of his solemn election promise. It is a sign of how arrogant and out of touch this Government has become that it is totally uninterested in what the British people want on Europe."

Elizabeth Beckett, presented to the courts legal representative three treason acts 1351, 1795 and 1848.

In 1998, in his Crime & Disorder Act, Tony Blair repealed the 1795 Treason Act which makes attempting to destroy the constitution into treason with a punishment of banishment.

However, in 1817 and the in 1848 statute, The Treason and Felony Act, it was

declared that the 1795 Treason Act was to be a permanent part of the British Constitution.

Elizabeth Beckett took the case on the three treason acts & on the illegality of the handing over of our fishing rights to Europe without any legal contract whatsoever.

The 1795 Act declares:

"Any person or persons, within the part of great Britain called England, ... maliciously and advisedly by writing printing or preaching or other speaking, express publish, utter or declare any words or sentences to excite or stir up the people to hatred or contempt of the person of His Majesty his heirs or successors, or the government and constitution of this realm as by law established that every such person and persons, being therefore legally convicted shall be liable to such punishment as may by law be inflicted in cases of high misdemeanour (banishment or transportation)."

An article by Thomas Hay chairman of the Fisherman's Association in Fishing News Feb 7th 2008, "A fearful legacy", demonstrated the illegality of the removal of our fishing rights. Magna Carta made clear that the fishermen had their liberties and free customs protected under The Coronation Oath: that our "freeholds or liberties or free customs cannot be removed".

In forcing the Queen to sign, despite her common law pre-eminence, therefore, Gordon Brown was acting treasonably and all this shows the illegal treatment of Britain by the EU - validated by the very politicians now forcing HM Queen to sign

away our British independence and our constitution.

Elizabeth Beckett, showed the lawyer the coronation oath in which HM Queen gave her solemn oath to protect our laws and customs and those of the dominions and colonies.

Similar to the fishermen, the people of the Chagos islands were turned out of freeholds and forced to leave their home and islands, by an earlier Fabian government under Harold Wilson. The appeal court judges in an appeal in may 2007, ruled that the Queen would not have allowed it if she knew what was being done in her name; that government was going behind the Royal Prerogative (the powers that we, the people give to the monarch for her lifetime for the purpose of protecting the people and our Christian constitution)

In the case of the Chagos Archipelago ruling neither the monarch nor parliament were involved in the order, a praemunire under the 1661 Act.

Elizabeth Beckett also handed on the Bill of Rights, 1669, which states that no-one can intercept petitions going to the monarch.

HM Queen, however, has not been permitted to read the EU treaties or petitions from her subjects in this regard: they all being diverted (initially by John Major, but also now by this government) to the Foreign and Commonwealth office.

This government is therefore displacing the monarch and treasonably preventing her

from protecting the people according to her Coronation Oath.

Last year the direct payments of the UK to the EU were £15B (this year more). This sum is sufficient to avoid and pay back the considerable Government borrowing indulged in by Gordon Brown as chancellor and his successor Alistair Darling, and to remove Britain from the alleged present economic difficulties.

The court lawyer told Elizabeth Beckett that her information would go directly to the Crown Prosecution Service or to the Magistrate. In ten days she has heard nothing.

Recently at the televised ceremony in The Mall, celebrating the coming of the Olympic games to London in 2012, Prince Harry was seen on the roof of Buckingham Palace, but Her Majesty the Queen was nowhere in evidence and did not appear as would be usual in the balcony of the Palace nor at Heathrow where Mr. Brown did the "honours".

COMMON PURPOSE BUSINESS 'LEADER', LEAVES TRAIL OF FAILED COMPANIES AND £ MILLIONS IN BUSINESS DEBTS.



Property magnate John Steven hits Plymouth Headlines after Evening Herald investigative reporter William Telford, exposed a string of failed companies and business debts.

A damning local press report reveals that Stevens, with former business links to former Director of the BBC Greg Dyke, owes £millions.

Just some of Steven's companies are linked to outstanding court judgements of £1.3 million according to local newspaper the Evening Herald. The article, dated 10 January 2009, also states that there are other firms, in liquidation, administration or wound up owing cash as well.

For local taxpayers the disclosure that the Plymouth City Council had allegedly sold to Steven's Wykeham Inns for the sum of just £1.00 (one pound), had left

the City with debts of £3,727, was clearly a shock.

This debt pales into insignificance however, against £1 million of European Objective One and Two loans made to Steven by Finance South West and other organisations. These loans are unlikely to be repaid, nor is £235,000 from InBev UK Ltd and £155,000 from Barclays Bank plc.

What the Herald neglected to tell readers is that Mr Steven is a Common Purpose trained "leader". One of thousands UK wide who are held up to be examples of elite leaders trained to 'operate outside authority'.....and Mr Steven certainly appears to have been doing that. Thanks to reporter Telford, the following list of unsatisfied County Court Judgements of 'leader' Steven includes: Alto Fairways Development Company £8,714, Bolero Leisure Ltd £880, Derriford Court Ltd £877,435, Lyme Projects Ltd £19,208, Saxon Hotels Ltd £20,343, Sound Build Ltd £126,516, Wykeham Group Ltd £88,510, Wykeham Homes (Plymouth) Ltd £1,147, Wykeham Homes (Millfields) Ltd £11983, Wykeham Homes (Torbay) Ltd £1,147, Wykeham Inns Ltd £30,943, Wykeham Land Ltd £164,435 and Wykeham Residential Ltd £1,147.

Members of the public will be puzzled as to how Mr Steven could have managed to run up such a portfolio of failure and debt and still have access to large amounts of cash via Finance South West, and obtained

valuable Plymouth City Council waterfront property such as Plymouth 'Dome'. What 'Due Diligence' was done to check the business background of Steven and his financial track record? Surely this is a simple and fundamental requirement for any public authority? Public concern will not be helped by the fact that as a Common Purpose 'graduate' Mr Steven will have operated in a network of public and private sector Common Purpose graduates, who are encouraged by the shadowy political 'Charity' to hold meetings behind closed doors and without minutes.

Reports and evidence held by the UK Column continue to show that where this secretive elitest network of Common Purpose graduates operates, there is often a trail of lies, deception and creative accounting with public money. Plymouth has been no exception amongst other major cities in the UK.

The UK Column can reveal that Mr Steven apparently attended an early Common Purpose meeting in 1999, entitled Regeneration Day which looked at regeneration development opportunities across the city. He later took a Matrix course. The meeting included Councillors and Officers responsible for planning, representatives from Plymouth City Council Housing, and civil servants from South West of England Regional Development Agency. Common Purpose documentation for the meeting included guidance on massive funding available from the Single Regeneration Budget. Under the Chatham House Rule, Common

Purpose advises graduates to operate without producing minutes of meetings. Luxury lessons in 'diversity'

Luxury lessons in 'diversity' for civil servants CIVIL servants are being sent to a luxury hotel for 'diversity' courses costing nearly £2000 a head, it was revealed yesterday.

The seminars are held over five days at the venue, which stands in 65-acre grounds and boasts a pool, tennis courts, a croquet lawn and a gymnasium.

The courses are run by the little known National School of government, an arm of the cabinet office at the Sunningdale park venue near Ascot, Berkshire.

Sessions involve 'role play with actors', and 'awareness workshops'.

Each bedroom has en-suite facilities, flat-screen TVs and complimentary wi-fi internet connection.

Included in the £1,755 cost of the 'Managing Diversity' course are meals, which are served in the Steam, Bake and Grill restaurant.

Among those sent on courses have been police officers, council tax inspectors and members of financial watchdog Audit Scotland.

Wiltshire Police, a small rural force, sent 20 employees on one course alone.

Shadow cabinet office minister Nick Hurd said: 'At a time when millions face losing their jobs, do ministers really think sending civil servants on diversity courses at a luxury hotel is prudent?'

And Mark Wallace of the Tax Payers' Alliance said: 'No wonder public services are struggling if civil servants' heads are being stuffed with politically-correct gobbledegook.'

However, testimonials suggest the courses are of benefit. Wiltshire Police force quality officer Adrian Williamson said: 'It has been a journey of greater understanding of diversity.'

A Government source last night insisted the Sunningdale complex was 'not a luxury hotel' but a cost-effective training facility.

Farming and Food - The plan to stop Britain feeding its people.

Twelve myths about the CAP

1) Myth: The CAP is needed because more than 50% of Europeans live in rural communities. (The BBC's claim)

Fact: In every EU country, more than 50% of citizens live in cities (therefore, the aggregate statistic for the EU is also over 50%). Every EU country is heavily urbanised, although the degree of urbanisation varies from country to country.

2) Myth: The CAP is needed because a large percentage of Europeans works in the agricultural sector, which also accounts for a large proportion of the EU's GDP.

Fact: Again, although stats related to these factors vary from country to country, across the EU as a whole only 4.4% of workers are employed in the agricultural sector, which produces only 2% of the EU's GDP. The CAP benefits few people but costs much money.

3) Myth: The CAP has been significantly reduced over the last 30 years.

Fact: Although slightly slower now than in 1984, when Mrs Thatcher negotiated the British rebate, the CAP nevertheless stands at 45% of the EU's budget, as opposed to 40% in 2005 and 66% in 1984. So 2005 was the lowest point for the CAP, having been reduced from 66% to 40% of the EU's budget, but has grown since then. And even in 2005, the CAP was the biggest program financed by the EU's budget, as it is today. The CAP is unreformable, so the UK must withdraw from the EU immediately.

4) Myth: The French did not get everything they asked for during the December 2005 EU summit.

Fact: They got everything they've requested. France has allowed only 'a review' of

the CAP in 2008 - but even despite this review, France wields a veto right, and French President Nicolas Sarkozy has already said that France will veto any deal that would reduce subsidies for French farmers.

5) Myth: The CAP is reformable.

Fact: The reforms introduced by Mrs Thatcher in 1984 have been reversed - CAP spending has increased again and will likely continue to grow, because the Polish government will, later this year, ask the EU to increase farm subsidies. Unlike the UK, whose 433 thousand farmers (1.4% of the labor force) produce enough food for 60 million domestic customers and for foreigners, Poland's 2.72 mn farmers produce only enough food for the 38 mn residents of Poland. The UK will never reform the CAP, so it should withdraw from the EU.

6) Myth: France lists agriculture among its priorities - but it appears to have a fair deal for European farmers and consumers in mind, rather than any bold initiative to remove trade barriers. (From the BBC's website.) <http://news.bbc.co.uk/2/hi/europe/7483486.stm>

Fact: Only a removal of trade barriers would be a fair deal for European farmers and consumers. A large chunk of the food consumed by Europeans is imported from abroad (e.g. bananas, which cannot be grown in Europe for natural causes). Moreover, the CAP is causing European consumers to pay many times more for food than they would otherwise have done. The free market, which Nicolas Sarkozy dislikes (as does his Trade Minister Anne-Marie Idrac, the former chief of the state-owned train operator SNCF), is the best tool to feed 500 million Europeans.

7) Myth: Mr Sarkozy has promised to "protect Europeans", worried as they are about high food and fuel prices. (From the BBC's website.) <http://news.bbc.co.uk/2/hi/europe/7483486.stm>

Fact: The only people Europeans need to

be protected are Eurocrats like Mr Sarkozy himself, who have led to high food and fuel prices in the first place. If it wasn't for Brussels' ethanol requirements and the CAP protectionist racket, the prices for food and fuel wouldn't have been high. To produce ethanol, you must use as much oil-derived products as you would have to produce any other agricultural product, PLUS petrol to power all lorries that would transport ethanol from ethanol factories to petrol stations. Also, ethanol is characterised by a worse gas-mileage than petrol.

8) Myth: Peter Mandelson is pursuing a deal that would reduce EU food production by 20% and reduce food exports - at a time of food shortages in the developing world. (From the BBC's website.) <http://news.bbc.co.uk/2/hi/europe/7483486.stm>

Fact: There are only two sorts of causes of those food shortages: a) ethanol requirements of the EU and America, and b) CAP tariffs and subsidies, which block food imports from the developing world while European farmers are being lavishly subsidised. The CAP is one of the reasons for why the Third World is poor. It's a vehicle designed to keep the developing world dependent on Europe.

9) Myth: We must not leave the task of feeding us to the free market. (Quote by Michel Barnier, the current French Agriculture Minister).

Fact: Michel Barnier is a member of the French Socialist Party. The free market is the best tool to feed everyone. It is the best economic model ever invented. The French etatist model is the worst, and consequently, the French economy is growing slowly. Yet France's socialist president, Nicolas Sarkozy, still believes that the EU has 'nothing to gain from emerging countries'.

10) Myth: The EU should subsidise farms because other countries (developed and developing alike) do.

Fact: Neither the EU nor its member states, if they ever become independent, should

model its policy on those of others unless there's a reason for that. In this case, there is none. Agricultural subsidies and tariffs are the very factors that drive up the costs of food and other commodities. As a result of the CAP, the prices of food and fuel are at their highest levels ever, accounted for inflation, and yet, disgraced liars such as Nicolas Sarkozy and Mariann Fischer Boel are still telling us that such policies are necessary to "keep food and fuel prices low and food abundant".

11) Myth: During the WTO Doha Round negotiations, which are linked to agricultural subsidies and tariffs, the EU has offered too much.

Fact: The EU has offered absolutely nothing whatsoever on its part. No tariff reductions, no subsidy reductions, nothing else. The EU has demanded that all others make unilateral sacrifices, while the EU keeps bowing to its domestic lobbyists. By contrast, the US proposed a multilateral 60% subsidy and tariff reduction on the part of developed countries, but this was rejected by the EU. To avoid undermining her own negotiating position, America is forced to keep its own, although less generous than the EU's, farm subsidies. Before the Doha round, there was a period, during the Clinton era, when the US didn't subsidise agriculture at all - after the Freedom To Farm Act was passed. But in the 21st century, Congressional Democrats, led by Tom Daschle (D-SD), reinstated farm subsidies.

12) Myth: France is the only EU state still opposing a WTO deal.

Fact: Ireland, as well as France, has already threatened to veto any deal that would require European farmers to sacrifice any subsidies or tariffs, and not only do these two states favour maintaining the current CAP spending levels (which would prevent a WTO deal, anyway), so do other 18 EU states. So protectionist, so communist, so socialist is Sarkozy that Brazil will wait for the WTO deal until 2012 - when the next French Presidential election will occur.

MI5 has resorted to a poster campaign in private London gyms to recruit more women from the ethnic minorities.

According to Whitehall sources, MI5 decided to advertise in gyms because "experience has shown that

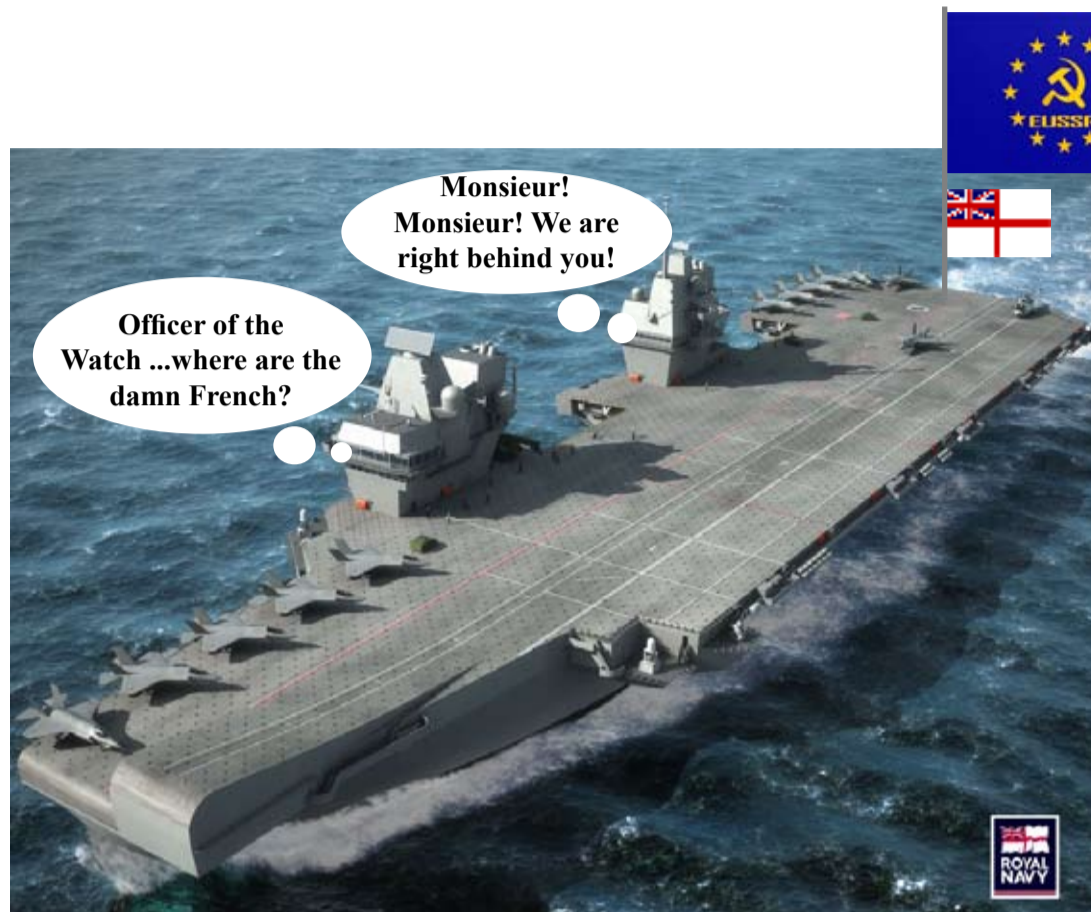
effective surveillance officers are generally physically fit, undertake plenty of exercise and enjoy an active outdoor life".

EU Control of UK Military



“Flash Flash Flash”

As the EU ‘locks’ Britain into its web of control, British ships are pawned out for European directed operations against ‘pirates’.....

Behind the scenes a French proposal would see a British aircraft carrier placed at the heart of a new EU naval group.

The plan for an EU naval force is being put forward by Nicholas Sarkozy French President.

Gordon Brown and Mr Sarkozy, with common purpose, are said to have discussed the plan earlier this year, and French officials have described the talks between London and Paris as “well advanced.”

What NELSON fought for, Gordon gives away behind the backs of a politically emasculated Admiralty, increasingly controlled by EU penetration into the forces’ Command & Control and Defence Development Sectors.

THE UK AND EU DEFENCE POLICY

In a recent Daily Telegraph article, the Conservative Shadow Defence Secretary Liam Fox criticises Gordon Brown for saying, inter alia, that the Lisbon Treaty “in no way affects our defence policy”. Fox points out that this treaty allows Qualified Majority Voting on defence topics and that it contains a mutual defence clause: the UK could thus lose its veto on defence topics and be sucked into conflict not of its own choosing. And as Gordon Brown is clearly in favour of getting the Irish to toe the EU line on the Lisbon Treaty, this issue is worth our current consideration.

How will the Tories ensure British Defence Independence?

Liam Fox’s criticisms would carry more weight if the Tories would or could state with clarity exactly how they could ensure British independence in defence issues.

There are only two honest approaches to this issue. The first is to say that we are happy to go along with whatever the EU wants in this respect, and that we regard this as more important than our defence relationships with the US and within NATO, and our ability to act independently on defence. The other approach is to say “none of the above”, and that we do not wish to be part of the European Defence Agency (EDA). (Whether we could stay completely clear of the EDA and still remain within the EU is debatable.)

The dishonest approach is to say that we

will stay good EU members and modify EU defence policy from within. This has always been Tory policy in all areas including defence. It has never worked, because when you are one of 27 you can never get at least 13 others to see things the way you do on important issues.

Muddled Tory thinking.

Yet the Tories keep trotting it out. The treaties of Rome, Maastricht and Nice – embedding us largely unwillingly ever more firmly within the EU *acquis communautaire* – are the palpable outcomes of Tory muddled thinking or equivocation or both. (Did someone pay somebody to get it so sorely wrong?)

Let us get back to the nuts and bolts of defence. Imagine you are an infantry soldier, or a fighter pilot, or a submariner – not a politician! When you are going into a fight in which you and your colleagues might die, whom do you want on your left and right wing? What backing, resources, skills, technology, technique, ethos and courage do you seek? Here is a short and necessarily incomplete list:

- Considerable backing from the parent government not only in terms of training and resources, but also in its commitment to supporting its military forces in an endeavour that has clear aims, justifiable motivation and a feasible “exit strategy”
- Good practical training that has honed the skills and motivations of the fighter
- Personal characteristics that include physical and mental strength, honesty and a dogged will to win.

Let’s be brutally honest. As I shall shortly show, there is no current member of the EU that comes anywhere near satisfying these criteria, except, perhaps..... Britain! (I include the “perhaps” because the present government is unwilling to back up commitments with sufficient resources.)

Experience from recent armed conflict shows that the nearest we have in the world to meeting these criteria are.....the Commonwealth nations (Canada, Australia, New Zealand, South Africa, India and a host of others too numerous to mention) and the USA. None satisfies all the criteria, none is perfect, but then again neither are we.

Inadequacies of EU’s collective military.

Let us be objective and not emotive in laying out the inadequacies of most current EU members in fulfilling the requirements of soldiers, sailors and airman for their fighting-mates. Any state with neutralist tendencies must be discounted. Very small states with obviously inadequate national resources must be discounted. States with a history of collaborating with a potential or actual invader must be discounted. States with a record of collapsing rather quickly in the face of armed aggression must be discounted. States with a record of political instability, and in particular any Fascist tendencies must be discounted. States that commit a very small proportion of their national GDP to defence must be discounted. States that are reluctant to deploy their forces into danger or to let them fight at night must be discounted. And perhaps above all, because we need to look after our own interests, states that have different national interests from ours must be discounted.

I rest my case. None of our EU allies can match up to our justifiably demanding requirements. And, to consider the last point above, it is nonsensical to think that we could get a common EU position on important issues in time to be useful, if ever.

The recent inability to get a common EU position on the conflict in the Gaza Strip bears recent testimony to this. In the 1990s Germany for reasons of its own unilaterally recognised Croatia as an independent state, bullied a weak and complaisant EU into doing so as well, and as a consequence unleashed ten years of conflict as the rest of the former Yugoslavian countries sought equivalent sovereignty and independence.

European Defence Agency does not make sense.

It beggars belief that anyone could genuinely believe that 27 sovereign nations could ever agree on complex areas of security and defence policy – yet the supporters of the EDA have to have such a belief or the whole thing does not make sense.

Of course it doesn’t. We must keep clear of such dangerous and muddled thinking. If the only way of achieving this is to keep clear of the EU altogether, then so be it.

The Sustainable Communities Act

The Sustainable Communities Act is drafted in such a way that local councils have to vote to adopt its requirements in their own area. It is supported by disparate bodies, some of which might be thought to be conservative in outlook, such as the Countryside Alliance, and the Women's Institute. It is also supported by such bodies as The Black Environment Agency, trade unions, and CAMRA, the Campaign for Real Ale. This might be thought amusing, however I contend that the Sustainable Communities Act is a cunning piece of legislation having as its intention the micro-management of our lives in the name of the environment.

The Sustainable Communities Bill promises action on things such as the retention of post offices and of local shops. It discusses taxation of supermarket out of town parking spaces. These promises may have attracted such organisations as the Countryside Alliance, Women's Institute and CAMRA. The Sustainable Communities Act was promoted by a cross-party group of MP's. Consult the Local Works website to learn more about it. The Act purports to facilitate action to improve local communities and the environment and has 'teeth'. Local Works informs us that the Act will do much more than just go through the charade of 'consultations' on matters of local environmental interest. Towards the bottom of the list of the objectives of the Act found on Local Works website, please notice 'Sustainable Development'. Who other than fuddy duddy reactionaries could oppose development that promises to improve our communities and environment in a sustainable way? Unfortunately the political concept of Sustainable Development is not very well

understood. It became concretised by a statement found in the Bruntland Report, 'Our Common Future', (Cambridge University Press) released during the 1987 United Nations World Commission on Environment and Development: The term 'sustainable' has become a buzz word that refers to a political agenda, rather than an objectively sustainable form of development. Specifically it refers to an initiative of the UN called Sustainable Development Agenda 21. Sustainable Development Agenda 21 is a comprehensive statement of political ideology that is being progressively infused into every level of government throughout the world. It is, if you will, collectivism by another name which is being achieved on the back of environmental concerns.

The European Union is fully signed up to the UN Sustainable Development Agenda. In Britain the Local Works organisation works out of 6 Cynthia Street, London, at which address is also to be found Charter 88, a Fabian Society front organisation. 6 Cynthia Street has been reported as being associated with Marxists or 'former Marxists'. In her book 'Death of Britain' Linsay Jenkins informs us that PEP, Political and Economic Planning, now called the Policy Studies Institute was the first Fabian front outfit. Thank you for your email on the above issue, please accept my sincerest apologies for the delay in replying to you.

The European Arrest Warrant (EAW) is designed to allow the arrest of criminal suspects and their transfer for trial or detention residing in one member state to another. The Arrest Warrant is an attempt to increase the

speed of extradition throughout EU countries, before the introduction of the common arrest warrant the extradition of criminal suspects took on average nine months. When a member state applies to join the Union, it must bring its judiciary up to high common standards. This is because all member states have an obligation to recognise court decisions in other member states, so for example if a British citizen committed a traffic offence while in France, the British government accepts that the French judicial system is free and fair and will not revoke the judgment made. However, despite having free movement and common recognition of judgments the process to extradite suspects was lengthy and often resulted in serious criminals avoiding justice in the jurisdictions in which their alleged crime was committed.

The value of the Common Arrest Warrant was seen recently when one of the suspects of the July 21 attempted bombings on the London transport system fled the UK to Italy. Given the serious nature of his crime and the potential for further such bombings it was vital he was returned to the UK quickly. This would allow the police to find out if Osman Hussein had information that could save the lives of ordinary British citizens. Thanks to the Arrest Warrant the police were able to build a case against Mr Osman and shut down a terrorist cell and its enablers and supporters in the UK.

I believe the Arrest Warrant can be improved further in ensuring proper protection of suspects' rights and to iron out differences between member states in the practice of the arrest warrant.

Thank you for letting me know your views on this important matter.

We are told that the science is "settled" and that we humans are somehow affecting the climate in a catastrophic way; that we are reaching a "tipping point" of no return. Yet, ask anybody in the street, and the answer is that "climate has always changed - it's natural and we are being conned". So what is the agenda of the press and the media? Isn't it their job to scrutinize and question what is being stated or do they blindly repeat what they are told? Shouldn't they be doing a bit of research?

In the Telegraph recently, Nigel Farn-dale quoted the term "global warming deniers" and these people (me being one of them) consider him to be gullible in swallowing the manmade global warming theory. Well, it seems that is exactly what he has done - hook, line and sinker.

Also in the Telegraph, Irwin Steizer thinks that 'green taxes' would be good for British jobs. He goes along with the idea that carbon dioxide is a pollutant and should be treated as such. Following this logic, we should all be taxed for exhaling the stuff?! Yet CO2 is a colourless, odourless, tasteless, non-toxic gas which is beneficial to plant life. Indeed there would be no life on earth as we know it without the stuff. Extra CO2 is often pumped into greenhouse to enhance crop growth. This was illustrated on Countryfile (BBC) when reporting on greenhouse production in Iceland.

The BBC knows no bounds in bias on this subject. They had Lord Turner and George Monbiot on air together, to discuss the Climate Change Bill blithely discussing the need for this tiny little country to reduce carbon emissions by up to 80%! Never mind that it wouldn't make a blind bit of difference because we produce just 0.08% of total world emissions - most of it coming from natural processes. There was no attempt whatsoever to challenge their predictions, assertions, or indeed the vast costs to the British public of what will go down in history as the longest economic suicide note in history. Why weren't Christopher Booker or Viscount Monckton invited to comment?

Back in the early autumn, one spokesman, possibly from the Met Office, was predicting a green Christmas, i.e. that there would still be leaves on trees. Well, he certainly got that wrong. How can we possibly believe their predictions on the climate for 10, 50 or even 100 years time. Climate is the most complex, non-linear, chaotic system known to man and, by definition cannot be predicted, aside from very short term forecasts in local geographical areas. Do you plan a bar-b-que three weeks ahead based on BBC weather forecasts? To ignore chaos is fraud. To claim that any unusual weather event may have been caused by manmade global warming is fraud.

I have followed the global warming debate for nigh on ten years having been directed to a website which set a few simple facts, not to mention some common sense:-
A sample of dry air consists of 78% ni-

trogen and 21% oxygen. The remaining 1% consists mainly of argon; 0.038% is the CO2 fraction (although admittedly rising) and we must not forget the evil methane at 0.000175%. We are told that these are "powerful" greenhouse gases. Yet the largest "greenhouse" gas is water vapour at 97% of all these gases!

96% of CO2 comes from natural sources - the remaining 4% from man's activities. Termites are believed to produce more than the whole of industrial USA!

Other significant factors affecting the climate include cosmic rays, solar magnetic cycles, sunspot cycles, changes in the earth's orbit around the sun, volcanic activity, changes in land use (land clearance, to name but a few.

Rising temperatures historically precede increases in CO2 not vice versa.

Changes in the amount of CO2 did not cause the Roman Warm Period, The Medieval Warm period or the Little Ice Age.

The rate of change in sea levels has not changes in at least the last hundred years.

The world's average temperature in the last century apparently increased by just 0.6 degC. It has been flatlining or even falling since then.

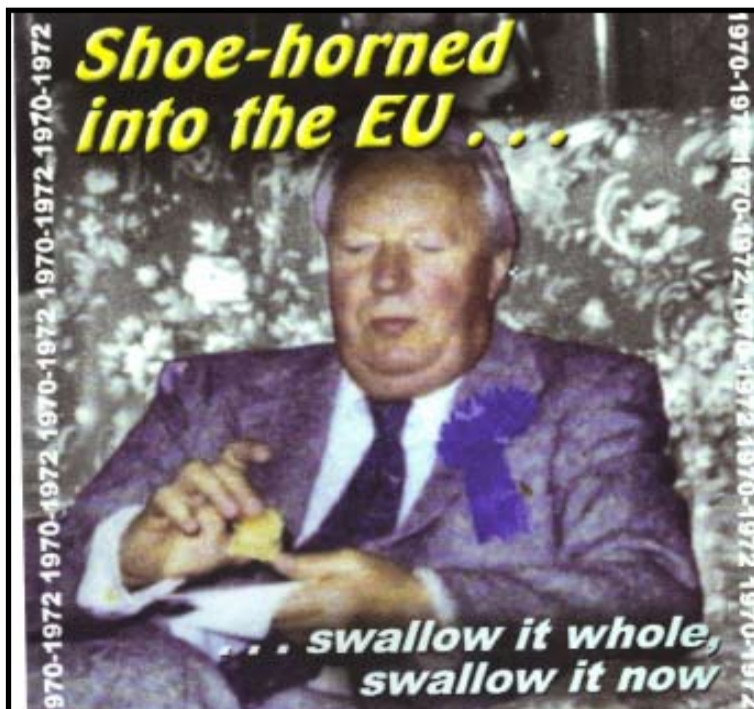
