URGENT

Dear Sirs

ELISH ANGIOLINI QC

We act on behalf of Elish Angiolini QC, the Lord Advocate for Scotland. We enclose a copy of an order granted by the Court of Session on 11th February 2010. An interdict (or injunction in England) has been granted by the Court of Session *ad interim* against Robert Green or anyone acting on his behalf or his instructions from communicating false and defamatory statements about Graeme Buchanan and harassing Graeme Buchanan by making false defamatory statements.

Your website contains false and defamatory material of our client and Graeme Buchanan. The purpose of this communication is to reiterate that you are hosting defamatory material and to inform you of the terms of the order granted by the Court of Session. The publication of false and defamatory statements and harassment continues with the material contained on your website. The material in question requires to be removed forthwith.

If the footage in question in question is not removed forthwith then proceedings may be raised for (1) defamation, (2) breach of interdict and (3) harassment. In the UK, harassment constitutes a wrong at civil law and can also be a criminal offence. Reference is made to Sections 2 and 9 of the Protection from Harassment Act 1997.

You should obtain urgent independent legal advice as to your position.

Act: Balfour

The Lord Ordinary, having heard Counsel on the unopposed motion of the Pursuer, made before calling, no caveat having been lodged, Allows the Summons to be amended, in terms of the Pursuer's oral motion made at the Bar, **(a)** by insertion of the words "or anyone acting on his behalf or on his instructions at or near the pursuer's place of work at Aberdeen Sheriff Court or elsewhere in Scotland" between the words "defender" and "from" where they appear in line one of the first conclusion; **(b)** by deletion of the name "Gordon" where it appears on the sixth line of the first conclusion and substitution therefor the name "Robert"; **(c)** by insertion of the words "or anyone acting on his behalf or on his instructions at or near the pursuer's place of work at Aberdeen Sheriff Court or elsewhere in Scotland" between the words "defender" and "from" where they appear in line one of the second conclusion; **(d)** by deletion of the word "hat" where it appears on the fifth line of the second conclusion and substitution therefor the words and numerals "and (iii) that"; **(e)** by deletion of the name "Gordon" where it appears on the sixth line of the second conclusion and substitution therefor the name "Robert"; **(f)** by deletion of the words "and by attending at the pursuer's place of work at Aberdeen Sheriff Court;" where they appear on the seventh and eighth lines of the second conclusion; **(g)** by deletion of the word "hat" where it appears on the fifth line of the third conclusion and substitution therefor the words and numerals "and (iii) that"; and **(h)** by deletion of the name "Gordon" where it appears on the sixth line of the third conclusion and substitution therefor the name "Robert"; thereafter, *ad interim* Interdicts the defender or anyone acting on his behalf or on his instructions at or near the pursuer's place of work at Aberdeen Sheriff Court or elsewhere in Scotland from **(1)** communicating false and defamatory statements about the pursuer to the effect (i) that the pursuer was involved in sexually abusing Hollie Greig or any other person; (ii) that the pursuer has been involved in covering up said sexual abuse; and (iii) that the pursuer has been involved in the murder of Hollie Greig's uncle, Robert Greig and in particular from displaying a banner or distributing leaflets containing such statements; and **(2)** harassing the pursuer and that by making false and defamatory statements about the pursuer to the effect (i) that the pursuer was involved in sexually abusing Hollie Greig or any other person (ii) that the pursuer has been involved in covering up said sexual abuse; and (iii) that the pursuer has been involved in the murder of Hollie Greig's uncle, Robert Greig and by displaying a banner or distributing leaflets containing such statements; and Decerns.
